Public Right-of-way Permit and Performance Bond

Know all men by these presents, that we, (Principal) and (Surety), a corporation duly incorporated under the laws of the State of are held and firmly bound unto the City of Newport News, Virginia, (City) in the full and just sum of \$ current money of the United States, to be paid to the said City, the payment of which we hereby bind ourselves and each of our heirs, executors, administrators, successors, and assigns, jointly and severally, firmly by these presents, sealed with our seals and dated this day of , 200

WHEREAS, The Principal hereunder will be granted permits by the City from time to time to work in, on, under or over the public rights-of-way of the City, and

WHEREAS, the City requires a bond in connection with each and every permit to work in, on, under or over the public rights-of-way, the said bond guaranteeing proper performance of the said permit, and

WHEREAS, the Principal is desirous of filing a single bond which shall cover any and all permits granted by the City to the Principal for the purpose of construction of driveways, entrances, sidewalks, and other similar construction in, on, under or over the public rights-of-way within the City, in accordance with the provisions of all ordinances that relate to such work.

NOW THEREFORE, the condition of the obligation of this bond is such that if the said Principal shall indemnify and save harmless the City from any loss that the City may sustain by reason of the Principal's failure to comply with any of the provisions of the permit or ordinances relating to the work so governed, then this obligation to be void, otherwise to remain in full force and effect.

THIS BOND will become effective on and shall remain in force for an indefinite

time; however, it may be cancelled at any time by the Principal or the Surety upon giving 30 days written notice to the Director of Engineering, 2400 Washington Avenue, Newport News, Virginia, 23607, of its intention to effect cancellation.
